## Congressman Hinchey Calls For EPA Action on Hydrofracking Waste

On March 1, 2011, Congressman Maurice Hinchey, whose District contains NYS lands most heavily targeted for gas exploration, sent a letter to EPA Administrator Lisa Jackson calling for immediate action to protect drinking water from the risks posed by wastewater and other materials generated by hydrofracking operations (hydraulic fracturing aka hydrofracking combines techniques for horizontal, pressurized drilling with additional proppants and chemicals to open and hold open gas-producing fractures in the shale).

Congressman Hinchey cited recent reports published by The New York Times about the special risks posed by the radioactivity of the wastes produced by hydrofracking. The Times article emphasized how poorly designed and prepared most sewage treatment plants are to treat the unique chemical and radioactive wastes generated by hydrofracking. To date, hydrofracking has not been allowed in New York, but hydrofracking operations in Pennsylvania have sought to treat wastes in New York sewage treatment plants.

## “Take a Dip for Canandaigua Lake!” Volunteer Water Quality Monitoring Program

In July 2010, CLWA's Lake Quality Committee partnered with Dr. Bruce Gilman, Professor of Conservation at FLCC, to pilot a volunteer-based water quality monitoring project: “Take a Dip for Canandaigua Lake!”

The pilot program was a success and CLWA was awarded a grant from the Ontario County Water Resources Council to purchase additional water clarity monitoring equipment for the 2011 summer monitoring season.

As a result, four groups of volunteers began to take readings at mid-lake off Deep Run, the Canandaigua Water Treatment Plant, German Brothers Marina, and Walton Point about every two weeks beginning in July and completed in September. The overall average depth recorded from 26 readings during this period was 6.04 meters or 19.8 feet. Not surprisingly, the highest overall average of 6.78 meters or 22.23 feet was recorded at Walton Point at the deep, south end of the lake. These readings, while from a limited number of samples, represent a marked improvement of water clarity over conditions in the 1980s. They also represent a reduction in clarity from the early-Zebra mussel days of the mid-90s.

The purpose of this project is to enhance the monthly water quality monitoring of Canandaigua Lake performed by Dr. Gilman for the Watershed Council by providing *more frequent measurements from a larger number of sampling*

We continue to advocate for the passage and strengthening of steep slope legislation in South Bristol and other watershed towns. We're paying for signage on storm sewer drains to stop people from pouring pollutants into them. Anything that goes down them goes directly into the lake. We're paying for two studies aimed at reducing sediment load into Sucker Brook at the north end of the lake and placing an ecological value on protecting land that protects water quality. Our partnerships with the Watershed Council and the Finger Lakes Land Trust are invaluable. They are assisting with the development and funding of these studies. Some members of our business community are stepping up to the plate, as you'll see in our membership list, and we're encouraging others to get on board. Because our environment is our economy, we need to better align ourselves with their environmental initiatives and vice versa. Hopefully you attended one or all of the seminars on hydrofracking that we co-hosted last week with the Finger Lakes Community College. We continue to provide community and school-based educational services because they develop our next generation of environmental stewards and keep us all informed.

Hinchey's letter to the EPA makes three requests:

1) To accelerate EPA's investigation into the risks hydraulic fracturing poses to drinking water

2) To require immediate and continuous monitoring of radioactivity levels and other toxic substances at sewage treatment plants handling hydraulic fracturing wastewater, as well as at drinking water intakes in close proximity to natural gas drilling activities, and

3) To reverse a 1988 EPA rulemaking that exempted wastes associated with the exploration, development or production of natural gas from the hazardous waste provisions of the Resource Conservation and Recovery Act (RCRA). **CLWA**

CLWA, together with Finger Lakes Community College's Wildlife Society and Finger Lakes Environmental Action Club, recently sponsored a series of talks and films at FLCC that approached the hydrofracking issue from a variety of perspectives, including industry proponents. Over 450 citizens attended and learned more about the issue.

*sampling points during the critically important summer months* when the greatest water clarity changes typically occur.

Collecting water clarity data with the help of volunteers is a cost-effective and widely accepted method for monitoring water quality. Many states including Minnesota, Maine, Illinois and Michigan, have statewide water monitoring programs utilizing hundreds of volunteers to collect weekly water clarity readings with Secchi disks. **CLWA**

### Volunteers needed for the 2011 Summer Monitoring Season! Interested in becoming part of the CLWA volunteer water quality monitoring project?

Requirements for volunteers interested in participation in the upcoming 2011 summer monitoring season include: 1) attending a mandatory hands-on training session, 2) having motorized or non-motorized access to the lake, 3) making a commitment to conduct weekly measurements from July through early September at a designated point on the lake according to a specified protocol, 4) submitting collected data using supplied data sheets, 5) maintaining monthly contact with CLWA Lake Quality Committee.

CLWA will provide you with training, data forms and monitoring equipment.

## **Open Burning Banned In NYS as of October 14, 2009**

---

New regulations pertaining to most large-scale open burning (including barrels and piles) are now in place. Trash burning is prohibited statewide. NYS DEC suggests that you recycle and compost to the fullest extent possible, and dispose of other waste in a legal manner.

There are some exemptions: small campfires, cooking fires and celebratory bonfires are allowed. Even with these fires, however, they may not be left unattended or unextinguished, and only clean fuel such as charcoal and clean wood may be burned.

Burning leaves continues to be banned in New York State. They can be composted. Chemically treated wood should not be burned. Open burning of household trash is banned because dangerous elements and compounds such as arsenic, carbon monoxide, lead, benzene and dioxin are created and released by such fires. In addition, open burning has been the single largest cause of wildfires in New York State.

Organic agricultural wastes are also exempted from this control, but they must be burned on an agricultural site of more than 5 acres and fully consumed within 24 hours. Burning pesticides, plastic containers and other non-organic wastes is prohibited. Prescribed burns can also be performed to achieve forest management goals but only with a permit from the NYS DEC. **CLWA**

## **Lake Levels**

Canandaigua Lake has been near summer levels (688.5 feet above mean sea level) for several weeks after both rain storms and snow melt caused runoff events in March. The gates behind Wegmans have been open since late February, and flow through the Outlet has been about equal to incoming flows.

Good, strong flows in major tributaries such as Naples Creek have led to excellent trout fishing conditions, and about 500 fishermen participated in this year's Naples Creek Rainbow Trout Fishing Derby. This year the Derby celebrates its 50th anniversary of founding in 1961, though it was cancelled in 1973 because of the in-stream destruction wrought by Hurricane Agnes in June, 1972.

Intense thunderstorms that arrived in the early morning hours of April 20, 2011 and continuing rainfall since then have boosted lake levels in recent days to 689.2 feet above mean sea level, about nine inches above the Guide Curve. These high lake levels together with 40-50 mph winds have been damaging to the shoreline. **CLWA**

## **Good News for Sucker Brook and the Lake: City Plans to Purchase New Street Sweeper**

---

Sucker Brook delivers runoff from over eight square miles of watershed in the Town and City of Canandaigua to Canandaigua Lake at the State Boat Launch. Over two-thirds of the City of Canandaigua drains through Sucker Brook, with no treatment, to Canandaigua Lake. Whatever goes down the storm drains on the east side of Main Street plus a large amount of the northwest quadrant of the City (including the Middle School) drains to Canandaigua Lake through Sucker Brook.

Urban runoff from cities normally contains pollutants that aren't good for streams or lakes. Hydrocarbons and heavy metals from our cars, waste from our pets, and fertilizers and pesticides from our lawns are common pollutants.

Effective street-sweeping can remove some of these pollutants. Older and less efficient street-sweepers were less effective at picking up pollutants; newer and more efficient sweepers work better. The City of Canandaigua has applied for a grant to cover about three-quarters of the cost of a new street sweeper. Such a grant would cover the public benefits in water quality that a new sweeper would bring.

Increasing concerns about the "nonpoint-source" pollutants carried by stormwater are adding new State regulations for its control. Though these regulations don't yet apply to Canandaigua, congratulations to City officials for seeing the connection and "doing the right thing" without being regulated. **CLWA**

# Ontario County Sheriff's Marine & Recreational Vehicle Division Activity Report 2010

The Marine and Recreational Vehicle (MRV) Unit operates year around and provides police services related to recreation related activity that takes place with boats, snowmobiles and all terrain vehicles in Ontario County.

This unit provides both education and law enforcement services related to the use of these recreational vehicles. During warm weather months, daily boat patrols are maintained on both Canandaigua and Honeoye lakes. Less often patrols are done on Canadice, Hemlock and Seneca lakes. Along with boat patrols on the lakes, MRV staff patrol areas that border the lakes, including parks, launch sites, and water treatment plants. They also answer calls related to navigation complaints on these waterways and aid disabled boaters as needed. During the winter season, MRV members provide snowmobile patrols as needed within the county. This unit also provides patrols using all terrain vehicles as needed in the county.

Members of the MRV unit operate 4 vessels, 2 of the boats are assigned to Canandaigua Lake, one is assigned to Honeoye Lake, and the other, which was put into service in late September 2007 is maintained on a trailer for use where needed. The Whaler boat assigned to Canandaigua Lake was replaced in 2008. In addition to the boats, the MRV unit maintains 2 snowmobiles and 3 all terrain vehicles. The MRV unit is also assigned 3 pick up trucks that are used to deploy crews and move equipment as needed. The trucks are also used by MRV staff to ensure that 24 / 7 emergency coverage is also available to handle responses to off hour calls for help. All 3 trucks are housed centrally at the old county garage in Canandaigua.

During the year 2010, members of the MRV attended training schools in basic vessel operation, advanced vessel operation, all terrain vehicle operation, firearms, AED / CPR, decibel meter training and other in service training topics.

In addition to their patrol work, member of the MRV unit maintain all of their assigned equipment on a daily basis. They do assist regular patrols with police service calls; assist with special detail events, including the Naples Grape Festival and several others. Staff from this division also provided educational programs for both boater safety classes and snowmobile safety classes on a regular basis. During the year 2010, they also provided assistance at the Ontario County Fair and distributed safety materials at the sheriff's display. Off season, members of the MRV are assigned to Eastview Mall and provided extra patrols during

the holiday shopping season. Their presence at the mall has help prevent thefts from parked cars for several years. While at the mall detail, they provide police services on a regular basis, including response to car crashes, and shoplifters.

## Newest Invader?

---

*Just when you thought it was safe to go back in the water...*

Invasive species are receiving a lot of attention recently, especially as compared with the relative silence greeting numerous invasions over the past fifty years. Most people have viewed the antics of Asian carp as they leap from the water in the wake of a motor boat's engine. As far as we know they are still not found in the Great Lakes or the Finger Lakes.

In recent years, the Great Lakes (and Finger Lakes) have been invaded by fishhook and spiny waterfleas, round gobies, and zebra and quagga mussels, most of them attributable to fresh ballast water carried through the St. Lawrence Seaway.

A new invader has been spotted in Lake Ontario, in 2006, and in 2009 in Oneida Lake: a tiny (2-9 mm), blood-red, freshwater shrimp by the name of *Hemimysis anomala*. The shrimp is native to the Caspian region of Asia Minor. Like its native relative *Mysis diluviana*, *Hemimysis* rises and sinks in the lake's waters, hiding from predators near bottom during the day and rising during the night.

Oneida Lake and the Erie Canal have traditionally been connecting points between the Great Lakes and the Finger Lakes, so it is likely *Hemimysis anomala* will become the newest species in the Finger Lakes. New species may travel down the canal, the Oswego River, in bait buckets, in the wells of boats, and, while microscopic in size, on the legs of gulls, ducks and other shorebirds.

Concern about *Hemimysis* is that it will displace the native Mysids, alter food chains and webs in the lakes, and encourage some fish, such as yellow and white perch, alewives, and rockbass which feed on it, and discourage others. Scientists are watching the *Hemimysis* populations in Oneida Lake to learn if it can survive its temperature extremes.

Unless there is a population explosion of *Hemimysis*, it's unlikely that you will see them, due to their habits. They are large enough to be visible to the naked eye, and their red color is distinctive. ## What Watershed Farmers Can Do To Protect the Lake— AEM Works

Agricultural Environmental Management (AEM) programs are a primary focus of Soil and Water Conservation Districts throughout New York State. Ontario County farms have participated in AEM since the inception of the grant-funded program. Thousands of dollars worth of cost-shared projects have been completed with the goal of reducing pollutant loading in streams and lakes. Farmers work with local AEM resource professionals to develop economically and environmentally sound Best Management Practices and plans specifically for their farms.

Justifying the large outlay of public and private funds required for the recommended practices and installations would seem to call for some quantifiable facts. Fortunately, those are available and clearly document water quality improvements when AEM practices are followed. Dr. Joseph Makarewicz, Professor of Environmental Science and Biology, SUNY Brockport, has undertaken such a scientific study in the Conesus Lake Watershed, located in Livingston County. The report was published in the *Journal of Great Lakes Research* in 2009.

Conesus Lake is a eutrophic (nutrient-rich) water body, four lakes west of Canandaigua. Algae blooms and macrophyte (water plant) growth have been recurrent problems, hampering recreational use and impairing aesthetic values. Although the lake has a shoreline urban corridor served by a perimeter sanitary sewer, other land uses are predominantly agricultural.

Seven subwatersheds tributary to Conesus Lake were selected for Makarewicz's study, offering a range of land size areas, daily discharge rates of streams and agricultural practices employed. The largest subwatershed (North McMillan Creek) was designated as a reference watershed and no AEM practices were implemented. Sampling of water was undertaken at the base of each watershed for the duration of the study.

Cultural and management changes (Best Management Practices: BMPs) on the farms in the other six watersheds were many, varied, and tailored to the needs of the individual farmers who volunteered to participate in the study. Soil testing (resulting in reduced fertilizer inputs), planting of cover crops, reduced tillage on erodible soils, elimination of winter manure spreading, were among practices implemented in various locations. Space does not permit a full listing here.

In general, significant reductions in total phosphorus, soluble reactive phosphorus, nitrate, total Kjeldahl nitrogen (nitrogen excreted from an animal) and total suspended solids were achieved by the second and third year of implementation. Sampling in the Graywood Gully subwatershed, where the most intensive best management practices were introduced, revealed the greatest percent reduction (average 55.8%, range 47%-65%) and the largest number of reductions in 4 out of 5 materials analyzed.

Historic records of macrophytes and algae dating back more than a decade were researched. Macrophytes, algal growth and filamentous algae (biomass) were monitored downstream in the nearshore areas of Conesus Lake for 2-3 years before the study and for 4 years during and after the installation of BMPs on subwatershed farms. Biomass decreased by 30-50% within one or two years of BMPs being implemented. Biomass in the subwatershed where no BMPs were introduced was statistically indistinguishable from pre-BMP years.

Two conclusions may be drawn from these ongoing studies. One is that Agricultural Environmental Management practices do work to protect water quality. The other is that there is often a 1-2 year time lapse between BMP installation and observable improvement in the receiving water body. As there is no practical or economic way to remove nutrients and sediments from a lake or other water body once these substances have entered, the time, effort and funds required for AEM work are well spent.
